REIMBURSEMENT OF TRAVEL COSTS TO CANDIDATES

Travel costs from the place of residence to Cagliari and *viceversa* will be paid in advance by the interested person and will be reimbursed by the Joint Managing Authority upon submission of the necessary supporting documents (a standard form to be filled in by the candidate will be provided by the JMA).

- Air travel: only economy class is allowed. Business class flights are not eligible and will not be reimbursed.
- Extra-urban train and public bus: their use is allowed as an alternative to air travel and for the transfer between the airport and the city center. First class is allowed on trains.
- Taxi use is allowed in exceptional cases from the airport to the venue of the meeting and *viceversa*, if there is no other alternative public transport available. The use of taxi will have to be duly justified by filling in a standard form provided by the JMA.

- Flight tickets: copy of the electronic or original ticket and all the original boarding passes.
- Extra-urban train and public bus: original validated tickets.
- Taxi: original taxi receipt together with the “Declaration on taxi fares” duly filled in and every other document useful for demonstrating the lack of alternative public transport.
- Travel agency: original invoice
- Entry visa: copy of passport
